Following discussion Alderman Nelson made a motion to approve Bill No. 1182 an ordinance establishing an amended budget for Fiscal Year 2024 for the City of Bel-Nor and Alderman Durand seconded. Alderman Days asked about posting for enforcement officer and Alderman McBride explained she worked with Debra Irvin and Alderman Nelson reached out to St. John's City Manager and that other cities have trouble finding code enforcement and inspectors.
